

ORDINANCE NO. 1220

**ORDINANCE LEVYING AND ASSESSING TAXES OF GREEN HILLS
PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, FOR THE
FISCAL YEAR BEGINNING JULY 1, 2022, AND ENDING JUNE 30, 2023**

BE IT ORDAINED by the Board of Library Trustees of the Green Hills Public Library District as follows:

Section 1: That the sum of THREE MILLION ONE HUNDRED EIGHTEEN THOUSAND EIGHT HUNDRED FIFTY-FIVE AND NO/100 DOLLARS (\$3,118,855) be and the same is assessed and levied from and against all taxable property within the limits of the said Green Hills Public Library District as the same is assessed and equalized for state and county purposes for the current year, 2022, and are to be applied in liquidation of the appropriations heretofore made by Ordinance adopted by the Board of Trustees of the Green Hills Public Library District at a meeting thereof regularly convened and held on September 19, 2022 and duly published as provided by law; the various objects and purposes for which said appropriations were made are set forth under the column entitled "Amount Appropriated" and the specific amount hereby levied for each object and purpose is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

The foregoing appropriations are appropriated from the proceeds of a special tax for corporate purposes. Said appropriations, less estimated amounts receivable from other sources, are hereby levied from the tax for general corporate purposes.

The foregoing appropriations are appropriated from the proceeds of a special .02% tax for the purchase of sites and buildings, construction and equipment of buildings, rental of buildings for library purposes and for maintenance, repairs and alterations of library buildings and equipment and are in addition to all other library district taxes as provided by law.

SPECIAL RESERVE FUND

The foregoing appropriation is hereby appropriated from the special reserve fund established by ordinance in compliance with Section 40-50 of the Illinois Public Library

District Act of 1991 (75 ILCS 16/40-50), whereby the Board of Library Trustees is authorized to transfer each year to the special reserve fund the unexpended balances of the proceeds received annually from public library taxes and to expend amounts accumulated in the special reserve fund for the purposes in the District's plan adopted pursuant to Section 40-45 of the Illinois Public Library District Act of 1991 (75 ILCS 16/40-45).
