ORDINANCE LEVYING AND ASSESSING TAXES OF GREEN HILLS
PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, FOR THE
FISCAL YEAR BEGINNING JULY 1, 2024, AND ENDING JUNE 30, 2025

**BE IT ORDAINED** by the Board of Library Trustees of the Green Hills Public Library District as follows:

Section 1: That the sum of THREE MILLION SIX HUNDRED TWENTY-FOUR THOUSAND TWO HUNDRED FIFTEEN AND NO/100 DOLLARS (\$3,624,215) be and the same is assessed and levied from and against all taxable property within the limits of the said Green Hills Public Library District as the same is assessed and equalized for state and county purposes for the current year, 2024, and are to be applied in liquidation of the appropriations heretofore made by Ordinance adopted by the Board of Trustees of the Green Hills Public Library District at a meeting thereof regularly convened and held on September 16, 2024 and duly published as provided by law; the various objects and purposes for which said appropriations were made are set forth under the column entitled "Amount Appropriated" and the specific amount hereby levied for each object and purpose is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:
